A. An <u>Ordinance Authorizing Contract Modification Number 3 with MS Consultants, Inc to the 2024 Basic Engineering Services Agreement.</u>

**Description:** This is Contract Modification #3 to the General Engineering Contract for MS Consultants, Inc. This Modification is for the Colonial Plaza Lift Station Generator Project in the amount of \$3,795.00

B. An <u>Ordinance</u> Authorizing the City Manager to Purchase A Western Star Dump Truck, Dump Body and a Snowplow and Salt Spreader.

**Description:** The city is buying a Western Star Dump Truck and Dump Body from T.S.I. Truck and Equipment Sales and we are buying the Snowplow and Salt Spreader from Gledhill Road Machinery. The cost of the dump truck and dump body is \$113,037.00 and the cost of the snowplow and salt spreader is \$84,406.54. This was in the budget for 2024 and purchased through State Purchasing.

E. A <u>Motion</u> to Authorize the City Manager to Apply for F-1 and F-2 Permits as Applicable from the Ohio Department of Commerce/Division of Liquor Control for Family Fun Night on September 19, 2024 and Fall Fest on October 5, 2024.

Description: Ohio Revised Code Section 4303.20 dictates how F-type (beer, wine, liquor) permits are treated in the State of Ohio. F-Permits are temporary and are utilized for special functions and can be issued to the City of Canfield.

The Ohio Department of Commerce/Division of Liquor Control issues temporary Type "F" Permits to certain non-profits, including cities to allow for this type of activity. The City of Canfield has previously hosted events in which an F-1 Permit was obtained. This motion authorizes the City Manager to apply for F-1 (Beer only) or F-2 (Beer and Wine) permits for the upcoming September 19, 2024 Family Fun Night and the Fall Fest on October 5, 2024.

# **SCOPE OF SERVICES**

# City of Canfield Colonial Plaza Lift Station Generator Project

April 17, 2024

#### **Project Understanding**

ms consultants, inc. (Engineer) understands that the City of Canfield (Owner) requests engineering services be provided to prepare bidding and contract documents for the above referenced project.

The Scope of Services for the project consists of the following:

#### 1. Basic Services

- A. Engineer shall prepare bidding documents based upon Ohio EPA Water Pollution Control Loan Fund (WPCLF) requirements and the generator technical specifications as provided by the City.
- B. Engineer shall develop an Exhibit conceptual site plan for inclusion in the bid documents.
- C. Engineer shall coordinate with the Ohio EPA to ensure that all WPCLF requirements are met.
- D. Engineer shall prepare a bid solicitation and send to three contractors as selected by the City.
- E. Engineer shall attend the bid opening and coordinate the bid opening with Owner's staff.
- F. Engineer will prepare up to one addendum as part of the project.
- G. The Engineer will prepare a bid tabulation based upon the bid results and prepare an award recommendation letter for the Owner.
- H. The Engineer shall prepare final contract documents and provide to the Owner for coordination with the awarded contractor.

### 2. Owner's Responsibilities

- A. Designate in writing a person to act as Owner's representative with respect to the services to be rendered under this Agreement. Such person shall have complete authority to transmit instructions, receive information, interpret and define the Owner's policies and decisions with respect to Engineer's services for the project.
- B. Assist Engineer by placing at Engineer's disposal all available information pertinent to the project including previous reports and any other data relative to design or construction of the project.
- C. Arrange for access to and make all provisions for Engineer to enter upon public and private property as required for Engineer to perform services under this Agreement.

- D. Furnish approvals, pay for and secure all permits from all governmental authorities having jurisdiction over the project and such approvals and consents from others as may be necessary for completion of the project.
- E. Attend meetings and provide timely comments.
- F. Give prompt written notice to Engineer whenever the Owner observes or becomes aware of any development that affects the scope or timing of Engineer's services.
- G. Furnish, or direct Engineer to provide additional services as stipulated in this agreement or other services as required in a timely manner.
- H. Bear all costs incidental to compliance with the requirements of this Section 2.

# 3. Assumptions/Exclusions

- A. The project scope does not include design of the generator or appurtenances. Engineer shall use the technical information already obtained by the Owner.
- B. Engineer assumes that the contract is complete once final contract documents are provided to the Owner. Engineer assumes that the Owner will coordinate all field work with the contractor.
- C. The scope of work does not include Environmental Review.
- D. Attendance at a pre-construction meeting is not included.
- E. Construction services are not included.
- F. Permitting is not included.
- G. This agreement assumes one bid. Re-bids are not included as part of the project.
- H. The Engineers Estimate shall be based on quotes already obtained by the Owner.

#### 4. Period of Service

A. The Engineer agrees to complete the bidding documents within two weeks of an executed agreement for submittal to the Ohio EPA for review.



# MINUTES CANFIELD CITY COUNCIL REGULAR MEETING

APRIL 17, 2024 -5:30 P.M.

The meeting was called to order by Mrs. Oliver, President of Council, followed by the Pledge of Allegiance. The Clerk called the roll to which a quorum responded as follows: Mr. Dragish, Mr. Graham, Mr. Neff, Mrs. Oliver and Mr. Tieche.

Staff present: Christine Stack-Clayton, Finance Director; Jodi Flinn, Zoning Inspector; and John Rapp, Public Works Superintendent.

Absent: Charles Colucci, Chief of Police.

Under PRESENTATIONS & PROCLAMATIONS, there were none.

Under **APPROVAL OF MINUTES**, the Minutes of the Regular Meeting on April 3, 2024 were approved as presented.

#### Under **READING OF COMMUNICATIONS**:

MR. TIECHE: I have none.

MR. NEFF: I had a resident, take me to task for what he considered not having all the facts on our position on the Fire merger. I said, "We're still open to listening to any new facts that come up." That was my answer. We made that decision because we felt that a very high percentage of our citizens were not interested. That's all I have.

MR. DRAGISH: I have nothing.

MR. GRAHAM: I have nothing.

MRS. OLIVER: The only thing that I had was the same thing, a resident questioning why we made our decision. We stand by our decision. At this point, it's not going to change, unless other facts or anything come forward. We haven't received any at this point.

Under **READING OF REPORTS** of Committees, Boards, Mayor's Report, City Manager, Finance Director, Chief of Police, Zoning Inspector and Public Works Superintendent.

MR. TIECHE: I do not have a report this evening our meeting will be next month.

MR. NEFF: Planning & Zoning meets tomorrow night, so I don't have a report.

MR. DRAGISH: I have the Mayor's Monthly Statement to Council. Monies received and who they were paid to and from, the net collections to the city was \$1,021.01.

MR. GRAHAM: I have no report this evening.

MRS. OLIVER: I'm on the Fire Board and our meeting is not until Monday. It's next Monday at 5:30pm, if anybody is interested in attending. Our Public Works Superintendent, Mr. Rapp.

PUBLIC WORKS SUPERINTENDENT: Good evening. Yarian is still working on Briarcliff and Bradford. They're into the restoration, taking advantage of the good weather. They were actually working as of 4:30 when I left that street. Our crews are out landscaping, mulching, you probably see them at the park and up here at the city building. We usually spend about a week to a week and a half on that, getting everything ready for spring. We've even started mowing. Limb and Stick, we were in zone 3 this week. We'll finish that up at the end of the week and we'll begin zone 4 on Monday. If you have any questions regarding rules and regulations or if your street is included in that zone, it's all on the city website. We will also be beginning lead & copper samples soon, I believe the 29<sup>th</sup>, right Patty?

CLERK: Right.

PUBLIC WORKS SUPERINTENDENT: We appreciate all the participants. A couple of years ago, they upped our lead and copper samples. They did it everybody, Niles, everybody that was fed from MVSD. We're at 40 samples every 6 months. We only had like 30 participants and now we just added like 30 more. We appreciate everybody's cooperation in getting the samples and leaving them on the doorstep for us. Also, we dropped the clock off to Mr. Oliver, he's going to start digging into that thing and it sounds like a hefty task but it seems like he's ready to do it.

MRS. OLIVER: He already started.

PUBLIC WORKS SUPERINTENDENT: That's all I have.

MRS. OLIVER: Thank you. Since you mentioned the city website, I would ask Mr. D'Apolito, if you could elaborate on that, since you've had some questions on social media reading the website. Thank you. Our Finance Director, Mrs. Clayton,

FINANCE DIRECTOR: Utility Online Bill Payment is currently unavailable. We've got in on our website and we put it out on social media today. Payments can be made at the municipal building during regular business hours or 24/7, there is a drop box in the lobby of the police department. We've starting moving all of the data from utility billing to the new software today. Tomorrow, we'll start proofing the bills that are produced out of the new software and we'll have to verify all of the customer information in the new software, once they populate all of that in. We're doing billings out of our current software and out of the new software and we're going to compare them. If anybody sees any errors in the next couple of months, please

contact us, as soon as possible, so that we can get it fixed. Hopefully, I'll have the online bill payment up, as soon as we get all of that verified, in the new software.

MRS. OLIVER: Thank you. Our Zoning Inspector, Mrs. Flinn.

ZONING INSPECTOR: Thank you, Mrs. Oliver. For the month of April, we issued 2 beekeeping permits, 4 garage sale permits, 7 zoning permits totaling \$215.00 for a valuation of \$34,746.00. Total permits issued for the year is 38, for a valuation of \$963,263. I have an update on a couple of projects, big one's that people have been asking about. We're waiting on a resubmittal of the site plans for the Hercules Car Wash. I did issue a permit for work to begin at the old IGA building, we're waiting on them to pick them up. The last thing, on Monday, I'll be going out to Millennial Moments for a sanitary inspection and this is on their second home of the year.

MR. DRAGISH: Do we know where the beekeeping permits were issued for?

ZONING INSPECTOR: I don't have the addresses but it was on Main and Broad, maybe.

MRS. OLIVER: Our City Clerk, Mrs. Bernat.

CLERK: Thank you. The Concerts on the Green schedule is finalized. It is available on our website. The concerts start June 10<sup>th</sup> and they run through August 19<sup>th</sup>, from 7:00pm to 8:30pm. This evening, the Civil Service Commission is administering the test for the Patrol Officer position; we had 7 applicants. That's all I have.

MRS. OLIVER: Thank you. Chief Colucci is not here. We'll go onto our City Manager, Mr. D'Apolito.

MR. D'APOLITO: Thank you, Mrs. Oliver. On behalf of the Chief, he's been off the last couple of days, on vacation. He wanted everyone to know that we will be meeting on Friday, the police department and some of the city hall staff, to set up the schedule for the city/police events, such as Movie Night, Safety Day, and Christmas in July. We're going to get that going again for this summer. We'll have those dates and times finalized.

I also want to take a minute to recognize Sam Oliver for his willingness to volunteer to get the clock restored. I know his work, he's incredibly talented. I'm looking forward to see how the clock turns out. I was also going to mention that it was delivered by Public Works to his shop on Tuesday.

Something that is important to a lot of people and we get many phone calls about Route 224 and Main Street, the patching job on the asphalt. We've been dealing with this for some time. We have had some very good negotiations with Lindy. I hope to have some resolution for council in the next week or so. I think we're going to get a really good result. I offered something that is a little different and I think they're receptive.

Finally, in regards to the city website. That is something that has caught my attention, since before I started here. It definitely needs a lot of updating. It definitely needs to have the links attached to it, as to where to go. The third-party vendor that we deal with here, I've been meeting with them multiple times, almost by-weekly. Our bill has been reduced greatly from where they started, when I first got here. I didn't think we were getting what we were paying for. They've been great about working with us. Ultimately, we'll decide whether it's going to be done in-house or a third-party vendor. Just to let everyone know, it's on my radar, it has been since I got here. Everything, everybody thinks about the website is correct. We're trying to make it a complete change. It will look very different in a short time.

MRS. OLIVER: Thank you. I will say, that clock is a lot larger in person. I thought the top of the clock was coming and it's all one piece. It's definitely large and heavy but I know he has good things planned to do to it, it's going to be beautiful.

MR. D'APOLITO: I was going to say something about him \_\_\_\_\_\_.

MRS. OLIVER: I like when you said it wasn't a wrist watch it's a clock.

MR. DRAGISH: I just want to say, a quick note, I noticed the carpet. That was one of the things I was going to say. I noticed it the other day at Mayor's Court on Monday. It smelled clean, it smelled good, it smelled fresh, and it looks fantastic. So, whoever, combination of things, it looks fantastic.

MR. D'APOLITO: I want you to know, I had absolutely nothing to do with this. (Laughter)

MRS. OLIVER: I thought those were new chairs for a minute because of the new carpet.

MR. D'APOLITO: They do match.

MRS. OLIVER: Last but certainly not least, our City Attorney, Mr. Fortunato.

ATTY. FORTUNATO: Really not report tonight.

MRS. OLIVER: Okay.

Under **PUBLIC QUESTIONS** on Reports:

MR. TIECHE: A question for Mr. Rapp. Do we take PFOS Samples?

PUBLIC WORKS SUPERINTENDENT: We do.

MR. TIECHE: Is that in conjunction with lead and copper? Is that a separate sample?

PUBLIC WORKS SUPERINTENDENT: It's a whole separate item. We have taken the samples but we do not have results yet.

MR. TIECHE: We get results back, then do our results go to MVSD?

PUBLIC WORKS SUPERINTENDENT: We keep an open relationship with MVSD. They will know what our results and we will know what their results are.

MR. TIECHE: Okay, thank you.

MR. D'APOLITO: It's all reported to the EPA.

PUBLIC WORKS SUPERINTENDENT: That is correct.

MR. TIECHE: I'm familiar with the process.

MR. D'APOLITO: Just for everyone else's clarification, that is who we actually report to.

MR. NEFF: Those samples are costly, to have them analyzed, right John?

PUBLIC WORKS SUPERINTENDENT: At this time, the U.S. EPA is funding the samples because they are getting together a baseline of the maximum contaminant levels for PFOS. We've been doing this for the past 3 years. Every so many months, they send us boxes, we send them back. We should be getting results back in the next couple of months. It takes a long time.

MR. TIECHE: The MVSD is in the process of designing a new filter for PFOS and that kind of thing, at the plant. They were part of a class action lawsuit as a settlement, I haven't heard exactly what the numbers are yet. I do attend their meetings on a monthly basis, so I sort of keep myself up to date on some of that.

PUBLIC WORKS SUPERINTENDENT: We just had a meeting with them last week and all communities received that water were at that meeting. They let us in on all that information. The engineering, they started the engineering process, they said by 2025, the summer of, the engineering is scheduled to be complete. They have a 2029 deadline for PFOS to meet.

MR. TIECHE: One of the interesting things that came about doing that study was part of the PFOS problems can be in the liquid that the fire service uses on chemical fires and that sort of thing, the Youngstown Municipal Airport changed their procedure so they're not adding as much PFOS to the water system.

MR. NEFF: John, one other thing, how are our residents doing with compliance on stick pick-up? Are we getting grass or any of the things that we've asked not to.....

PUBLIC WORKS SUPERINTENDENT: We're doing really good. No complaints. So, anybody that does have something, it was minor infractions, they will be notified by the door hanger. I think there has only been a couple.

MR. NEFF: Thank you.

MRS. OLIVER: Residents, any questions on the reports that you've heard? Hearing none.

#### Under Recognition of Persons Desiring to Appear Before Council:

MR. JOHN MORVAY: John Morvay, 7 Willow Way. First of all, I'll preface by once again thanking members of council for serving. I've been there. I've been on that seat and I know that sometimes it's a thankless job. I just wanted to thank you before I make my comments.

I'm going to start with the Cardinal Joint Fire District merger. We've heard the proverb or saying, if it's not broke, don't fix it. I don't think we should be that shallow in our planning. I sat on the Fire District Board for 15 years. I know the finances. I was enlightened by what they were trying to do with the additional revenue and economy to scale, combining those forces together. It made all the sense in the world. It seems like everyone's self-interest was put before the priority, of the whole. We lost sight of the benefit that would be acquired by everybody by the merger. Not to exclude anybody but the union, the city, the township, nobody gave it a chance. Again, I sat on this board for 15 years. It would have been a great benefit for both communities. It would have given us additional services and we probably would not have had to come back for another levy. These fire truck are not 3 to 3 ½ million dollars, they will be 4 million dollars here shortly, ambulances are a couple million dollars to equip them with the right equipment and such. Just my comments, I think we were short sided on that. We should have studied it. Here is another saying or Proverb, We made our bed, now we have to lie in it. It's not going to go. I've talked to several parties and it's not going to happen with any information that comes out. I don't' believe that council stood together in that decision. I don't think individuals would stand together with that decision, based with increases in the next couple of years.

Some residents are probably going to be upset with me, this is the pump track issue. I want to thank Lex Calder for expanding our resources at Fair Park, similar to what we did at Greasel Park with the Pickleball Courts. God forbid, people are there and it's vibrant. Kids are there and enjoying it. That's terrible. In the paper, there were 60 residents that are concerned about the noise, traffic and safety. My grandchildren live right there. They live right at Fair Park. I'm at that park almost every night with them. I've never had anybody disrespect or mistreat or any concern whatsoever about safety or hoodlums or whoever they think is going to embark on there. I'd encourage before any decisions are made that people go out there and yes, there are football teams out there, baseball teams out there, there are kids playing on the playground. That's what you want in a park. That's why we build parks. If we're not going to use them, let's just close them down. (Mr. Morvay was reading from the newspaper) An Akron Police Officer asked me why anyone would want to put one next to the playground. They're talking about the

pump track. Again, God forbid, the kids come and use it. It says here, kids on the playground, equipment, dogs walking. Yeah, it's a neighborhood park. Again, why do we have a park, let's encourage that. That's what it's for. In that same article, Lex Calder was called out that he's building a personal playground for himself and his children. I think that's wrong. I think that's a form of bullying. It's okay not to want the park there or the pump track there but don't make personal attacks on people that put their time, effort. Lex has donated time, talent and treasure in building this park and encouraging this pump track. All he has asked in the past was what else do we need? Do we want to put a bocce court in? He's throwing out ideas. Don't attack him personally. My final comment, if we're not going to encourage this kind of utilization and build where there is more usefulness to these parks, let's just close them down. Thank you.

MRS. OLIVER: As you know, Mr. Morvay, I have the utmost respect for you. You're like a mentor to me. You always have been. I agree with you on using the park. I'll have to respectfully disagree in regard to the fire merger. As you know, I sit on the board now, and with being on that board a very short time and sitting there with Mr. D'Apolito as well. It was made very clear to us that, that was going to happen whether we like it or not by a few individuals. Unfortunately, the only information they ever showed us was all the pro's of doing this. We all know that all things come with pro's and con's. Nothing can be 100% good. There is going to be something that's negative. But they didn't have anything negative. They made it clear that they were getting it done and it was going to happen very quickly. So, we made a unified decision to stop that from happening, until we had more information. Once it's done, it's done. Then the fallout would begin, where it would affect people with things that are unknown at this point. That is why we made our decision. So, they couldn't go and just put something in place without anybody else knowing. They kept us in the dark. They still have to this day. They have not given us information. This committee that they say they have consisted of two people. I don't know about you but I've never anywhere where a committee has only two members. So, that is why we made our decision. I can say, we stand by that. Those are the reasons.

MR. NEFF: I would like to comment, I'm surprised that John, you're saying that it's closed. I think we made the decision that, as of now, we're against it. We didn't say that we wouldn't be looking at additional information and facts, if they came out. I don't know how everyone else feels but I thought we just agreed to, at this point in time, with the information that we have, that we would be against a merger. I thought that that Fire Board is still researching. I would think that our council is open and forward thinking enough, we'd review new facts, if they came out or when they come out. That's just my comment. Thanks.

MRS. OLIVER: That's exactly what I feel we all believe up here. Any other comments? Anyone else wanting to speak, please state your name and address for the record.

LEX CALDER: Lex Calder, 145 Willow Bend Drive. I'm sorry I missed the meeting last time. I read about it. I saw it. It was probably better that I wasn't here, I guess. I was in the woods in a log cabin with my family and my friend. We were in Gatlinburg for a couple of days to gymnastics regional finals for my son, who got a medal. Congratulations to him. Two things I

want to address, I'm not the President of the Parks Board. That was in the paper. I'm the Secretary. I took over J.T. Whitehouse's position. Two, the personal piece was a little bit puzzling to me. You guys have all been here with me the whole time. I assure you, I did not join the Parks Board, I don't volunteer at the school and the PTA. It's not just for my children. I'm not trying to improve this for my own personal use. I'm trying to improve this whole area to help give new amenities. I believe that parks should be more diverse. They should attract a bigger slice of the population than the up to 4<sup>th</sup> grade. There is nothing to defend here. I don't know Norma. I've never met Norma. I'd love to sit down with her sometime and have her understand what I'm doing and where I'm coming from. I appreciate all your support throughout this time. This has been by the book. I started the idea, brought it to you guys, got money from the state. I got home from Fayetteville, Tennessee. We stopped by a park there, kids were playing, had some lunch. I have a 3-year-old that is 95% potty trained, so we have to stop a lot. My kids came running over and were so excited, they said, dad there is a bike track here, right next to the playground. This is not an odd thing. This is very normal throughout the country. I've shown locally, all the parks within a 60 miles radius. All I'm trying to do is bring that culture to give new things for us to do, to give the new generation of kids that have opportunities through biking. One time I was there, there was a professional biker that was there, he's a cyclist around here, sponsored by a local shop, on a BMX Bike. He said, it's the first time I've been on my bike in 16 years because there is nowhere to ride them. We used to build our own tracks with plywood, they break and you fall. He said, this is awesome to have this. This will get a whole new generation of kids that are into it. That's what I'm trying to do. I appreciate your support. I just wanted to put that out there for the record.

MRS. OLIVER: Thank you. Is there anyone else desiring to speak before council?

#### Under **COUNCIL COMMENTS**:

MR. DRAGISH: Without getting into any of the issues of both of these topics; which I could probably include the bee but I won't. Nothing against the media or newspapers or anything like that but I think a lot of this back and forth in the papers. I've been to all of these meetings, obviously and I hear all the information from both sides so, the decisions we make here, and we really haven't made any decisions, to be honest with you. The decisions made here are by the facts that come into us. If people want to read the papers and slam people, that's fine but we didn't say that to you. That's my feeling about this. We take the facts and we make our decisions on the facts. Nothing else, not hearsay, not questions that are not proven or complete. That's my comment.

MRS. OLIVER: Thank you. Mr. Graham.

MR. GRAHAM: Well said, Mr. Mayor. I believe we look at the facts before a decision is made and I appreciate everybody's input. I concur with what you previously said. A number of questions, if I live in the city or the township, how this was all going to be worked and to this point, I haven't received that information. Thank you.

MR. TIECHE: I have no additional comments.

MR. NEFF: I would like to thank you, Lex. I think it's really wonderful when residents step up and try to help our community. We really do have a beautiful park in Fair Park, it's 40 acres. Years ago, we did a study to put in a bike lane around Canfield and try to connect the schools and make a big circle. I hope we can continue with that and find funding and grants. It might eventually lead to a connector from the bike path. Good job. We are always open to hear people's concerns and try to react accordingly.

MRS. OLIVER: Thank you, Mr. Morvay and Mr. Calder for coming out this evening. Exactly what Mayor Dragish said, we make our decisions that we feel is in the best interest of our residents, based on the information that we have. Unfortunately, we have no information further, then what we already said. That is why we have our decision the way that it is at this time. Thank you, very much for coming out and expressing how you feel. I would like to adjourn this meeting. Do I have a motion to adjourn?
