AN ORDINANCE PROVIDING THAT A CHARTER AMENDMENT SHALL BE SUBMITTED TO THE ELECTORS OF THE CITY OF CANFIELD FOR ADOPTION OR REJECTION AT THE REGULAR MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 5, 2024, PURSUANT TO SECTION 7.08 OF THE CHARTER OF THE CITY OF CANFIELD AND ARTICLE 18, SECTION 9 OF THE CONSTITUTION OF OHIO AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Canfield desires to amend the Charter of the City of Canfield pursuant to recommendations from the City Administration; and

WHEREAS, newspaper publication costs related to city legislation, meetings and contracts has increased tremendously, and

WHEREAS, The Ohio Legislature has passed legislation authorizing publication by other means; and

WHEREAS, the council of the City of Canfield, desires to submit a Charter Amendment authorizing publication by alternative means to the electors for adoption or rejection at the regular Ohio Municipal Election to be held on November 5, 2024 in the City of Canfield.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CANFIELD, OHIO:

Section 1: That a Charter Amendment shall be submitted to the electors of the City of Canfield for adoption or rejection at the regular Municipal Election to be held on November 5, 2024, pursuant to Section 7.08 of the Charter of the City of Canfield and Article 18, Section 9 of the Constitution of the State of Ohio as follows:

To amend various sections of the Charter to allow that required notifications and publications may alternatively be placed on the City's website, the City's social media platforms and posted at City Hall, in lieu of publication in a newspaper of general circulation.

Section 2: That the amendment stated in Section 1 above shall be effective January 1, 2025, provided said provisions are adopted by the electors at the regular Municipal Election to be held on November 5, 2024, in the City of Canfield, Ohio.

Section 3: The Clerk of Council is hereby directed to certify the foregoing proposed amendment to the Board of Elections of Mahoning County, Ohio for submission to the electors of the City of Canfield as provided by law.

Section 4: It is recommended that the amendment herein proposed shall be designated on the ballot by its descriptive title as hereinafter set forth. The adoption of such amendment by it descriptive title shall have the effect of adopting the amendment in full, as proposed by Ordinance. Form of the ballot to be used in submitting the provisions of said amendment by its descriptive title at the regular Municipal Election shall be as follows:

Shall the Charter of the City of Canfield be amended to allow that required notifications and publications may be placed on the City's website and social media platforms and posted at City Hall, in lieu of publication in a newspaper of general circulation

Section 5: That the Board of Elections of Mahoning County, Ohio shall certify to the Council the City of Canfield the results of the vote upon said amendment, and if said amendment is approved by the majority of the electors voting thereon, it shall become a part of the Charter of the Municipality of Canfield as hereinbefore set forth.

Section 6: Upon Certification to the Council by the Board of Elections of Mahoning County, Ohio, that the amendment proposed in this Ordinance shall have been approved by a majority of the electors voting thereon, it shall be the duty of the Clerk of Council to certify a copy of said amendment to the Secretary of the State of Ohio, as required by the Constitution of the State of Ohio.

Section 7: That the Clerk of Council is hereby directed to publish the passage of the proposed amendment pursuant to Article XVIII, Section 9, of the Constitution of the State of Ohio and Section 731.21.1 of the Ohio Revised Code.

Section 8: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Canfield, Ohio. Said emergency exists by reason of the deadline to submit to the Board of Elections for the November 5, 2024 ballot.

Section 9: That this Ordinance and all deliberations relating to the passage of this Ordinance were held in open meetings of this Council, all pursuant to Section 121.22 of the Ohio Revised Code and Section 3.11 of the Charter of the Municipality of Canfield.



CANFIELD CITY COUNCIL REGULAR MEETING JUNE 26, 2024-5:30 P.M.

The meeting was called to order by Christine Oliver, President of Council, followed by the Pledge of Allegiance. The Clerk called the roll to which a quorum responded as follows: Mr. Dragish, Mr. Graham, Mr. Neff, Mrs. Oliver and Mr. Tieche.

Staff present: Charles Colucci, Chief of Police; Jodi Flinn, Zoning Inspector and John Rapp, Public Works Superintendent.

Absent: Christine Stack-Clayton.

Under PROCLAMATION & PRESENTATIONS:

MRS. OLIVER: I know that we have a Proclamation this evening, Mr. Mayor.

MR. DRAGISH: I would like to say, from all of us up here, and the whole city, congratulations you guys did a wonderful job. Taking the championship was awesome. It's cool to see such a young group of girls work really hard to get that final thing. I just want to say, congratulations again from all of us. With that being said, I have a Proclamation for you.



WHEREAS, the hard work, dedication, sportsmanship, talent and exceptional team chemistry of the 2024 Canfield High School Girls Softball team has enabled these student athletes to earn a State Championship title; and

MICHAEL KERNAN: Boy, do I love Canfield! We're really excited about any recognition we have. The support and energy from the community was second to none. For me to come over here and do a state runner-up and a state championship, these kids were incredible. The community is incredible. The support is incredible. The excitement, it's just there. We're really, really proud that you had us come here today and recognize us with this proclamation. I'm speaking for the team. I'll tell you how great these kids are, they are 10-15 minutes before the practice, I haven't seen anybody really tardy all year. I might have to have Macy do 5 push-ups. (Laughter) they are great for being on time. Thank you, very much. We appreciate everything, we're very proud to be a part of it and make it happen here in Canfield. Thank you. (applause)

Under **APPROVAL OF MINUTES**, the Minutes of the Regular Meeting on June 5, 2024 were approved as presented.

Under READING OF COMMUNICATIONS:

MRS. OLIVER: Does anybody have any communications?

MR. DRAGISH: I think that people of Canfield are very happy that the Main Street, 224 is being paved today. I took a video going into work this morning. I'm getting some wonderful remarks. With that being said, kudos to you. Thanks for making it happen before the 4th of July. It's looking good.

MRS. OLIVER: Great minds think alike because I also took some pictures, while I was going down 224 because I'm excited, so I can share. I also have some exciting news. My husband Sam has finished our clock. In fact, it was finished before we went on vacation and we just returned yesterday, so the clock is ready to go and be on the Green again. So, we're really excited to see our clock come back.

MR. TIECHE: Good job, Sam.

MR. DRAGISH: Thanks Sam.

MRS. OLIVER: He worked hard on it. I can attest to that. It's nicely packed, wrapped up and ready.

MR. D'APOLITO: If possible, I'd like to see if we can install it prior to the 4th. Even if we do a ceremony afterwards. If we can have that up for the 4th.

MRS. OLIVER: I think that's a wonderful idea.

MR. D'APOLITO: (inaudible)

MRS. OLIVER: I think that could be accommodated. That would be nice, the ceremony with BEN from BEN'S CLOCKS and everybody involved.

MR. DRAGISH: That would be nice.

MRS. OLIVER: Do you think that could be done, Mr. Oliver?

PUBLIC WORKS SUPERINTENDENT: We'll get it done.

MRS. OLIVER: Sounds good. I don't have anything from last week. We were on vacation. Anybody else? Hearing none. We'll move on to reports.

Under **REPORTS** of Committees, Boards, Mayor's Report, City Manager, Finance Director, Chief of Police, Zoning Inspector and Public Works Superintendent.

MR. TIECHE: I just attended the Mahoning County Meander Water District Meeting and they talked about all kinds of things, from new videos that they're working on about the water plant out there, grants that they're working toward on the PFOS removal; which is something new that the EPA is coming up with. Some other changes such as, rebuilding clarifiers at the plant. A lot of things with regard to the plant that provides us our water. It's rather extensive but if you ever get a chance you make a phone call and you can get a tour and see what all goes on with regard to how our water is treated in our section of Mahoning County.

MR. NEFF: I have nothing for Planning & Zoning. I'll refer to Ms. Flinn for the report.

MR. DRAGISH: I have the Mayor's Monthly Statement to Council. The fines, monies collected or received, net collections to the city a total of \$840.01.

MR. GRAHAM: I have nothing for Design Review.

MRS. OLIVER: Our Fire Board Meeting was on Monday, it was the only one I wasn't available to be at because we were out of town. I have the total calls for 2024, actually it's only updated to May. It says, May was 205, there were no fire losses in May, there were 91 ambulance transports in May, 2 mutual aids were given and 2 mutual aids were received. We had 6 firefighters that were considered for 3 positions. Josh Grossman was sworn-in to Lieutenant and he will progress to be Captain on the A-turn because we had a retirement of Captain Troy Kolar. We have Shawn Serich (spelled phonetically) who will be sworn-in from firefighter to Lieutenant on C-Turn and Eric Vogel will be sworn in from firefighter to Lieutenant. It looks like our fire department is growing.

MR. TIECHE: Were the number of calls that you referred to were just the Month of May's calls or was that year-to-date?

MRS. OLIVER: Yes, month of May.

MR. TIECHE: I thought you had said, year to date.

MRS. OLIVER: They had all of them listed out. I reported on each one. So, those are the main numbers. Of course, I don't have the June numbers yet.

MR. TIECHE: Okay. Thank you.

MRS. OLIVER: You're welcome. Let's move on to our Public Works Supervisor, Mr. John Rapp.

PUBLIC WORKS SUPERINTENDENT: The CCR Reports are in the mail. Those are required by the EPA once a year for water quality that we receive from MVSD. They should be arriving, if they haven't already. It should be that tri-fold with all the requirements.

We had a water break on Callahan on Sunday. We repaired that in a few hours. It was actually a really quick one.

Our own guys are going to (inaudible) to that Pirate Ship at Fair Park. It's falling apart. Tim Long is going to work on that throughout the day. I'm going to try to get it back to being safe again. Right now, there are screws popping out and the wood is failing. We're going to try to rehab that and get it back to where the kids don't have to worry about getting a splinter or the nails. Much needed repair on that.

Crews completed the street painting, in cross walks and a lot of those things on the side streets. A company called Shur-Line, they did all the main streets, on 224 & 46. So, we kind of split those duties.

Finally, we installed the Historical Marker by the gazebo, it turned out really nice. In that process, Patty actually received a call on Tuesday morning after the concert on the green, a

gentleman lost his dentures. I told the guys about it. They were down there in the afternoon and they ended up finding the gentleman's dentures. We bagged them and brought them up here and he was super happy and appreciative.

MRS. OLIVER: He should be an air tag on them. (Laughter)

PUBLIC WORKS SUPERINTENDENT: We were trying to figure out why he took them out and set them on the ground.

MR. DRAGISH: Only in Canfield.

PUBLIC WORKS SUPERINTENDENT: They do it all, these guys.

MR. TIECHE: He may have been singing along.

PUBLIC WORKS SUPERINTENDENT: That's all I have.

MR. TIECHE: The water report that was mailed out, did we develop that or was that a collaboration between MVSD and

PUBLIC WORKS SUPERINTENDENT: It was a collaboration between MVSD, the City of Canfield and the Gemini Group who actually puts the information together, we proof it, they send it out and mail it to all the residents.

MR. TIECHE: It was a very good report.

PUBLIC WORKS SUPERINTENDENT: Did you receive it already?

MR. TIECHE: Yes. I even read it.

PUBLIC WORKS SUPERINTENDENT: Good.

MRS. OLIVER: Mrs. Bernat will be giving the Finance Director's report.

CLERK: The State Auditor's have finished their work in our office. The final Audit Report will hopefully be available in August. The next meeting, Chris will have a budget adjustment on the agenda. She also plans to have a rate adjustment ordinance for water. RCAP has finished the water rate study.

MR. TIECHE: Do you know anything about the water rate study? Is it going to be plus or minus?

CLERK: I do not.

MR. TIECHE: Okay.

MRS. OLIVER: Our Zoning Inspector, Mrs. Flinn.

ZONING INSPECTOR: Thank you, Mrs. Oliver. Our last Planning & Zoning Meeting was held on June 13th. The item on the agenda, Planning approved a recommendation to replat lots 2246, 2673 and 2247. That was the only item on the agenda for that night. For the month of May, we issued 12 garage sale permits, 29 zoning permits, totaling \$16,360.00. Total year to date, for permits is 85 with a valuation of \$4,600,000. I did want to say a special thank you to John, Justin, Jim and Tyler. They helped me yesterday and today with a resident. It was really great and helpful in teaching me new things and I appreciate it.

MRS. OLIVER: What was new? What did you learn?

ZONING INSPECTOR: We were camering a sanitary. I hadn't seen the videos before and being involved in that in finding a lateral. A little bit of a messy job. It was informative.

MR. TIECHE: Did you get to climb in the manhole?

ZONING INSPECTOR: No. Maybe next time.

PUBLIC WORKS SUPERINTENDENT: She got to see what was in the pipes.

MRS. OLIVER: That made you not want to climb into the manhole. Good job. Our Police Chief, Chief Colucci.

CHIEF OF POLICE: Thank you. This past Saturday was Safety Day on the Green. It was one of the lower attended events that we've had but it was a good crowd. The heat was up there. The city manager came out and got to see what we do on Safety Day. The Fraternal Order of Police, our local chapter, purchased hamburgers and hot dogs, pop, chips. The Sheriff's Department was there. It was a good event.

The Fireworks are on Saturday, June 29th at 5:30PM. The 4th of July Parade is on the 4th of July, on Thursday. We have a kids foot race in the morning. At 10:10, as always, the Parade leaves the Fairgrounds at Gate 5 and will proceed north of 46, will probably get to the square around 10:25. Thank you to the 4th of July Committee. It's a small group this year. It increased the workload for everybody. They're all fantastic. They did a great job. They care a lot about the community. The donated a lot of time and hours. A big event that I'm excited for, it's a police department sponsored event, it Christmas in July, it annual. We handed out a lot of fliers this past weekend. Our officers stopped at businesses, really trying to promote it this year. Toys that we will donate to Akron Children's Hospital, we work together with Akron Children's Hospital to do Christmas in July. I'm formally asking John to put the Christmas Tree in the gazebo for that. We'll do the square with Christmas decorations that day. Last year, Santa came in on jet skis. We'll see what we can do this year. Maybe Santa will have a new idea.

MRS. OLIVER: Santa can come in wearing a swim suit and carrying a surf board.

CHIEF OF POLICE: That's July 25th, Thursday at 4:00 pm to 8:00 pm. Probably one of the most attended events, other than Fall Market on the Green is Saturday, August 17th, 11:30-4:00 PM, it's Choose Joy for Melina. The goal with that event is to raise awareness and funds for pediatric brain cancer research. We always work together with that group. They do an amazing job. The raffles are amazing, the baskets are amazing, good people to work with. I spoke with Beth Paddock (spelled phonetically) everything is set for August 17^{TH,} at 11:30am, she's on that committee.

We got a new digital speed sign that we ordered for East Main. I'm sure some of you noticed that half of them are burned out, some of our older signs. We were able to purchase that speed sign with forfeited drug money. Things that we budgeted for out of the General Fund, we chose to use the drug money for. That's it.

MRS. OLIVER: Thank you. I remember that Safety Day is always very nice. My daughter did it one time when she was little. I'm sure the heat had something to do with the attendance. I heard it was much warmer here than where we were.

CHIEF OF POLICE: We had commercial fans for our Chef, Lieutenant Ruiz.

MRS. OLIVER: Our City Manager, Mr. D'Apolito.

MR. D'APOLITO: Thank you, Mrs. Oliver, just a couple of highlights over the past few weeks. The Pickleball Courts at Greasel are in full swing now. There were 2 courts that were unable to be used. We finally got the company out to repair those courts. They are repaired, painted, all 6 courts are open for play. Whenever I drive through there, there is a crowd in the morning and afternoon. It's great to see. The Pickleball Courts are in great shape. The basketball Courts are painted at Fair Park. It was an additional painting job after the striping but they look fantastic. I did want to follow-up about Safety Day. I want to acknowledge and thank the officers and fire fighters that came out and gave their time. It's great to see the children interact with them. They do a great job. I want to recognize Lieutenant Ruiz and his wife again, they were on the grill all day. I also want to piggyback on the pirate ship. We were at Fair Park for a safety meeting and afterwards we were looking at the Pirate Ship, we received some complaints. We thought about getting it repaired, replaced or just eliminate it. While we were over there, a young girl came over and said it was her favorite piece of equipment at Fair Park. Tim from Public Works came over, he's very talented, he said he would be able to repair it and do it inhouse much cheaper. I just wanted to give Tim special recognition for stepping up for the City. Finally, a small little thing, East Main Street has been paved. (Laughter). Mr. Tieche, day 178, of my administration.

MRS. OLIVER: I was just going to ask that question.

MR. D'APOLITO: Almost 6 months here at the City. I'm excited.

MRS. OLIVER: I heard from Mr. Rubin today, our middle school principal, he's thrilled about those Pickleball Courts. He says, thank you. He's very grateful.

MR. DRAGISH: I just wanted to add to what you have on your list. I think there has been a lot of progress shown at the old IGA Plaza. A lot of progress going on there. The formation of the exterior of the building, the roof being completed and then also on the Farmer's Building. It's really coming into shape. When you leave town for a little bit and you come back you can really see the difference. The day to day, you don't see it. When you go and come back you can really see the difference. I think there are some major movements happening and I'm excited.

MR. D'APOLITO: Sometimes people say some negative things about these projects but for people to make those investments in the city, we really need to recognize that and appreciate what they're doing. Those are big investments and big risks.

CHIEF OF POLICE: I spoke with the owner of the project over there. The design that he gave to us last year is what's happening; not much is going to change. That beautiful look that they showed us, that's what we're going to have.

MR. NEFF: I wanted to ask Chuck, I heard that they're to expedite the old cars in the Parade, they're going to put them off 20 minutes before the Parade starts. I don't want to start this as a rumor. Have you heard anything?

CHIEF OF POLICE: No. Lieutenant Ruiz is the liaison with the committee. I hadn't heard that yet. I know there was talks.

MR. NEFF: When they're in the center of the Parade, I heard some of them overheat, they go out side by side and then all of a sudden they go, one by one.

CHIEF OF POLICE: Sorry.

MR. TIECHE: Will we be getting information from the Parade Committee as to timing and all of that kind of stuff. What time we're supposed to be at the Fairground?

MR. NEFF: It always goes off at 10:10.

CHIEF OF POLICE: At 10:10, we leave and typically.....

MR. TIECHE: They said something about being there at 9:30am.

CHIEF OF POLICE: 8:30, 9:00, 9:30, the City Manager will have that for you.

MR. DRAGISH: Usually, for the most part, not that I need that but for the most part, you show up and your stuff is already set in line. Wherever your name is at, that's where you go.

MR. TIECHE: Yeah but the pumpkin barn is gone.

MR. DRAGISH: It is gone.

MR. TIECHE: If I'm going to be looking for a pumpkin barn, I'm not going to find it.

MR. DRAGISH: I did hear today, I know that this has been, over the years, it's been a frustration on the part of the committee and the people that are in the line, that there were never any restrooms open. I guess they're going to have those that are right there, so we don't have to walk clear across the fairgrounds to use the restroom.

CHIEF OF POLICE: Good point. Enid called first thing this morning about that. Bev confirmed that they will be open.

MR. DRAGISH: Just an FYI for everybody.

MRS. OLIVER: Our City Attorney, Mr. Fortunato.

ATTY. FORTUNATO: No report tonight.

Under Questions on Reports:

MR. MORVAY: John Morvay, 7 Willow Way. I do have a couple of questions for John, number 1. John, the water study, was there any abnormalities? I read the report.

PUBLIC WORKS SUPERINTENDENT: No. Not at this time. We're in the process of doing UCMR5; which is your PFOSS. We haven't received those results yet. We're going to be looking at that. That is something we have to have out to the public, I think within 1 year. It will be on our next CCR Report. Other than that, the only abnormal reading was and this could be just be errors on the sampling, there were 2 places out of the 40 samples we took that were elevated in the lead. Of no concern, it wasn't a violation. We fell under our 98 percentile in calculations. All in all, I think it went very well. Other than that, everything else checked out good.

MR. MORVAY: I got a new meter. I didn't receive a bill but I got a late notice. Are we still sending bills out?

CLERK: Yes, we're still sending bills out.

MR. D'APOLITO: You can apply with the city manager for a waiver of those fees. It will be looked at.

MR. MORVAY: I did. I didn't hear back.

MRS. OLIVER: John, if it makes you feel any better, about a year ago, I called for the same reason because I never received a bill. It happens. It's the post office.

MR. MORVAY: Just as a side note, Sam I want to thank you for restoring the clock. It's beautiful. I just want to note, Rotary does so much for this community. We rebuilt the gazebo, we did the band shelter out at the school, we do so much for this community. Rotary donated \$1,000 to Sam to help with the project. The working of the internal, the sandblasting, etc. I just wanted that noted, that Rotary did give \$1,000 for that.

MRS. OLIVER: I do have the invoices to send over to you. For Ben's Clock Shop and the sandblasting. All of the other parts, Sam paid for those but the Rotary is wonderful and they will be part of that plaque.

MR. MORVAY: just make sure I get the invoices and I'll get a check from Jane.

MR. DRAGISH: As part of the Rotary, just to give a plug, I don't think they were mentioned as part of the things coming up this summer. August 4th is the wine gala on the Green.

MR. MORVAY: It's an excellent event. Rotary is asking the city to help out with security and maybe the trash. I know the trash is an issue but the monies that we collect at this wine gala go right back into the community. Kind of one hand helping the other. If you can help out with the trash and the police, that would be wonderful.

MR. D'APOLITO: Is the liquor permit applied for?

MR. MORVAY: Chief?

CHIEF OF POLICE: You'll have it.

MR. MORVAY: Did we do it online, like you said?

CHIEF OF POLICE: Yes, he's working on it.

MR. MORVAY: Okay.

MRS. OLIVER: I have tickets to sell too, so don't get them from John.

MR. MORVAY: Mine are already sold.

MRS. OLIVER: I was going to say, mine are already sold.

MR. MORVAY: Keep me in the loop, if you would, Chief.

CHIEF OF POLICE: For sure.

MR. MORVAY: Thank you.

MRS. OLIVER: Any other questions on any of the reports? Hearing none, we'll move on.

Under **RECOGNITION** of Persons Desiring to Speak Before Council:

MR. MORVAY: John Morvay, 7 Willow Way. This is my wish list. Spending a lot of time at my grandchildren's home on Oak Street. Around dinner time, 5:30, 6:00, 6:30pm, that park is really utilized. There are a lot of practices going on, a lot of kids at the playground and that street gets really busy with traffic. Chief, sometimes, they're probably going a little too fast. One of the things that I looked at was right there at High Street and Oak Street, that bend. If there was a stop sign there on both streets, that would slow that traffic down somewhat. I understand that ODOT may have some say in that. That's fine but you can research this but I think in 1980, there was a little girl killed there, that was never solved. It was a hit and run. It was right at that bend. I don't know if you would remember anything about that Mr. Tieche.

ATTY. FORTUNATO: ODOT really governs those issues, John. We look for the warrant. We do the traffic study and if the warrant says, it's an issue for the city to place traffic control devices that are outside ODOT (inaudible).

MR. MORVAY: There are two roads connecting, so I don't know, maybe it's possible to get two stop signs there. That would slow that traffic down. You also have people from 62 cutting across and going to 46. You get that a lot.

CHIEF OF POLICE: One of the things we can do is the speed trailer. It captures data.

MR. MORVAY: Because I spend so much time over there, I witness that. Second of all, those roads are a wreck. Kirk is pothole, pothole, pothole. All the side of the road is gone. That part of Oak by Fair Park is really bad. I don't know where it is on the list of priorities to be paved. Maybe we can look at that and move it up.

PUBLIC WORKS SUPERINTENDENT: John, I'll get that done for you this year, it's on the list.

MR. MORVAY: One other thing, at the last council meeting we passed an Ordinance not to allow the marijuana dispensaries. That's fine, I understand all those concerns but just like the gun range and the growing of the marijuana that we passed the Ordinance here, those places are businesses and it's legal and it brings business and money into this community. We should pretty much study that before making decisions to not bring different types of businesses into town. Not that I'm advocating marijuana or anything like that but if you don't think that people smoke it and take the gummies, there are probably more people in Canfield (inaudible). Those

are legal entities and they bring revenue to the city. We should be open-minded about not just carte blanche, cutting them off and not allowing that commerce in here. That brings me to this Segway. Mayor, I think we ought to bring back the business forum, like once a month. That was strong in bringing business owners together. It's a great networking time. I believe that maybe we should bring that back in.

MR. DRAGISH: I'm up for that.

MR. MORVAY: I'll help out. I've got the list from the prior ones. We can make up an invitation list. I can help you with that.

MRS. OLIVER: Thank you, John. I remember when we did that business forum. I have information from that too. That was a good thing. Thank you.

MR. TIECHE: Just for your information, High Street was last paved in 2017, Oak Street was 2004.

MR. D'APOLITO: Oak Street is on the list this year.

MR. TIECHE: I know it is. I'm just saying.

MRS. OLIVER: Any other questions? Hearing none.

Under **OLD BUSINESS**, there was none.

Under **NEW BUSINESS**:

ITEM A: An Ordinance Approving the Replat of Lots 2246, 2673 & 2247 on Timber Run Drive and Topaz Circle by Robert & Roberta Raymond, Ramesh Dangol and Patricia Homan.

MRS. OLIVER: As per the provisions of Section 4.05 of the Charter of the City of Canfield, I move that Council dispense with the requirement of two readings of the proposed Ordinance and authorize adoption of the same upon its first reading.

MR. DRAGISH: Second.

ROLL CALL ON MOTION:

5 Votes-Yes 0 Votes-No Motion passes.

MRS. OLIVER: As per the provisions of Section 4.05 of the Charter of the City of Canfield, I move that Council dispense with the requirement of a full reading of the proposed Ordinance and authorize reading by title only.

MR. TIECHE: Second.

ROLL CALL ON MOTION:

5 Votes-Yes0 Votes-NoMotion passes.

MR. TIECHE: Madam President, I have An Ordinance Approving the Replat of Lots 2246, 2673 & 2247 on Timber Run Drive and Topaz Circle by Robert & Roberta Raymond, Ramesh Dangol and Patricia Homan. I move for passage.

MRS. OLIVER: Do we have any discussion on this Mr. D'Apolito?

MR. D'APOLITO: I'm not aware of any. If the Attorney wants to speak to it.

ATTY. FORTUNATO: Basically, the way replats work are, applicants survey the property, they provide a mylar, it goes to MS Consultants to determine whether our requirements are satisfied in terms of the yard size, etc. When MS certifies it, Planning & Zoning approved it and then it comes to Council. That is where we're at. MS has reviewed this and certified that it complies with our requirements of our ordinances, meaning that it satisfies the requirements of being a legal lot. We would recommend your approval.

MR. NEFF: Second.

MR. TIECHE: As a result of these replats, are we going to see any requests for adjustments for a structure on these lots?

ATTY. FORTUNATO: I don't know. That may happen. That's really not part of this consideration. We look to see what they're doing, size wise, dimension wise. If it is, we approve it. We have to approve it. Whether there will be an adjustment for some planned use, we don't know that yet.

MR. TIECHE: I understand but I guess my thought would be think about that in advance before you come up with a replat because now you've changed the lot size that may create a problem.

ATTY. FORTUNATO: That's the applicant's job.

MRS. OLIVER: Any other questions? Hearing none. Roll Call.

ZONING INSPECTOR: These have houses on them already. It's just cleaning up the lot lines. One neighbor that just moved in is giving a little bit of her land to the neighbor behind her and she is taking a little from the neighbor beside her for a pool and pool house to stay 5 feet off the property line, just to make things a little cleaner.

MR. MORVAY: Just adjusting. Thank you.

MR. DRAGISH: That's very nice that they're doing that.

MRS. OLIVER: Any other questions? Hearing none.

Under **COUNCIL COMMENTS**:

MR. NEFF: We applied and have a people mover reserved for the people that want to ride in the parade on the people mover. It's a 14-seat people mover. We're not going to fill it up. So, if any of our hardworking friends of the city would to join us and ride in the parade rather than just attend, I think we'll have time.

MRS. OLIVER: Thank you. About how many seats do we have?

MR. NEFF: We have myself, Mr. Tieche and Mr. Graham.	
MR. GRAHAM: Grandkids.
